This Memorandum of Understanding (MOU) entered into on 20/01/2021 is witnessed and signed by the following persons: Oriental University, India (Plot: Borewell Road, Near No. 1, Indirapuram, Greater Noida, India) and JWAIA Mahila Samiti (Plot: near Ganga Prasad College, New Palasia, India).

WHEREAS The Voice of Women Samiti entered as "Mahila" organization in India, which is a non-governmental organization engaged with the mission of providing financial and social security through health & economic resources to women from diverse sections of the Indian society. The Samiti has been recognized and registered a center of social as well as occupational independence under the government of India.

WHEREAS the Parties have decided to cooperate and work in response to some of the social issues to enhance the effectiveness of their organizations.

WHEREAS, through friendly relations, by and to improve and development of women for a bright future of the country and create an economic front for the good development and working women.

PROVISION 2.4. General University agrees to work in collaboration with South Central Federal Government and South Government authorities, especially with respect to:

PROVISION 2.5. General University and South Central Federal Government agree to support a 50/50 split of funding to the South Central Federal Government.

The provisions of general agreement are:

1. **Administrative Participation:** General University will work with South Central Federal Government and South Government to understand gifts and other assets and help them become South Central Federal Government assets. General University will continue to provide and maintain records for work closely with South Central Federal Government.
2. **General Government Support:** General University will work with South Central Federal Government and South Government to understand their needs and support them in the development of records to make South Central Federal Government a beneficiary for the same.
3. **Operational and Planning Programs:** General University will coordinate with South Central Federal Government and South Government to provide support to the development process. General University will continue to provide and support South Central Federal Government in work closely with South Central Federal Government.
4. **Health:** General University and South Central Federal Government will jointly take up health and hygiene activities for gifts and assets. These activities may take up in the form of health camps and initiatives or affordable services that improve their medical health and hygiene.
5. **Medical Transportation:** General University will provide for medical and health care services for all the general government employees and staff assigned to South Central Federal Government.
6. **Other Social Activities:** General University and South Central Federal Government will jointly coordinate health camps and activities such as social activities and recreational activities for the welfare and development of South Central Federal Government gifts and other assets through clubs and other welfare activities in South Central Federal Government.
7. **Environmental Responsibility:** General University will be responsible for all the environmental activities being provided by South Central Federal Government and South Government providing the records against with South Central Federal Government.

It is agreed that other party to South Central Federal Government, general government, including, but not limited to, the use of public resources that are not intended for the other party to South Central Federal Government will belong to all of South Central Federal Government.

The MRA shall be subject to amendments resulting from the normal and periodic reviews and adjustments of value of the parties. If there are any disagreements about the terms of this agreement or its operation or progress submitted by the MRA, both parties agree to resolve these submitted matters by mutual consent and effort and agreement in good faith & mutually agreeable resolution.

The MRA between National University and Trade will be in force unless terminated by either Party. Either Party may terminate this MRA by giving 30 days written notice to the other Party. The MRA shall be governed by the laws from the state of signing of the MRA. The agreement can be further amended by the mutual consent of both the parties.
