



## Memorandum of Understanding

This Memorandum of Understanding (hereinafter referred to as “MOU”) is entered on by and between Oriental University, Indore Opp. Rewati Range, Gate No.1 Jakhiya, Sanwer Road (hereinafter referred to as “Oriental University”)

And

JWALA – The Voice of Women (hereinafter referred as “Jwala”), headquartered in Indore, which is a Non-Government Organization created with the mission of providing financial and social security, through easily - accessible resources, to women from diverse sections of the Indian society. The foundation have incorporated and implemented a model of social as well as environmental responsibility within the organizational framework.

**WHEREAS**, the Parties share similar missions and wish to cooperate in areas of mutual concern to enhance the effectiveness of their development efforts;

**WHEREAS**, Oriental University understands the need for upliftment and empowerment of women for a bright future of the country and wishes to cooperate Jwala for this good cause that they are working towards;


**WHEREAS**, Oriental University wishes to work in collaboration with Jwala towards Human Development and Social Empowerment initiatives, especially with respect to women.


**THEREFORE**, Oriental University and Jwala can have mutual beneficial association by way of signing a MOU in the areas of their interests.

The core areas of mutual cooperation are:

- **Education Participation:** Oriental University will work with Jwala in educating, counseling, mentoring and empowering the underprivileged girls and other women and help them become financially self-reliant. Oriental University will nominate interested and competent faculty to work closely with members/officials of Jwala for the same.
- **Women Empowerment Drives:** Oriental University will work with Jwala in organizing and being a part of women empowerment drives raising awareness about the development of women to make them capable enough to earn a livelihood for the family.
- **Educational and Mentoring Programmes:** Oriental University will undertake some educational and mentoring programme with Jwala to guide women participants in the empowerment process. Oriental University will nominate interested and competent faculty and other staff to work closely with members/officials of Jwala for the same.
- **Health:** Oriental University and Jwala will jointly take up health and hygiene initiative for girls and women. These initiatives may take up in the form of health check up and workshops on affordable nutritional diet, awareness camp, menstrual health and hygiene etc.
- **Student Volunteering:** Oriental University will provide its students and faculties as volunteers free of cost for pre-identified events/rallies/awareness drives organized by Jwala.
- **Other Social Activities:** Oriental University and Jwala will jointly conduct charity events and donation drives, social activities and outreach activities for the inclusive development of underprivileged girls and other women through clubs and other working societies in Oriental University.
- **Environmental Sustainability:** Oriental University aims to cooperate in all the environmental sustainable activities being promoted by Jwala and undertake to take up activities promoting the similar agenda with Jwala.

In no event shall either party be liable for any indirect, incidental, special, consequential damages, including, but not limited to, loss of profits, revenues, data or use, incurred by the other party in connection with, arising out of or under this



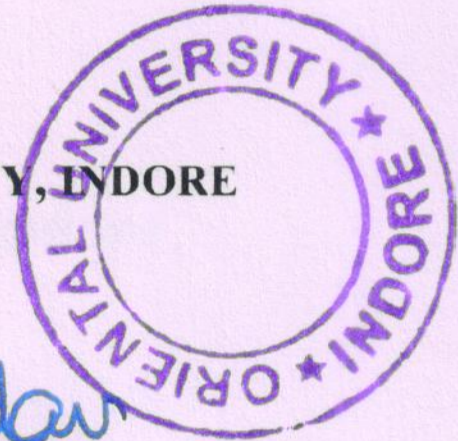

MoU save for any such loss suffered resulting from any willful and grossly negligent act or omission of either of the parties. If there are any disagreements about the terms of this agreement or the operation of programs authorized by this MoU, both parties agree to refrain from unilateral action, to consult with each other and negotiate in good faith a mutually agreeable resolution.

The MoU between Oriental University and Jwala will be in force unless terminated by either Party. Either Party may terminate this MOU by giving three (3) months written notice to the other Party. The MoU shall be assumed to be in force from the date of signing of the MoU. This agreement can be further renewed by the consent of both the parties.




