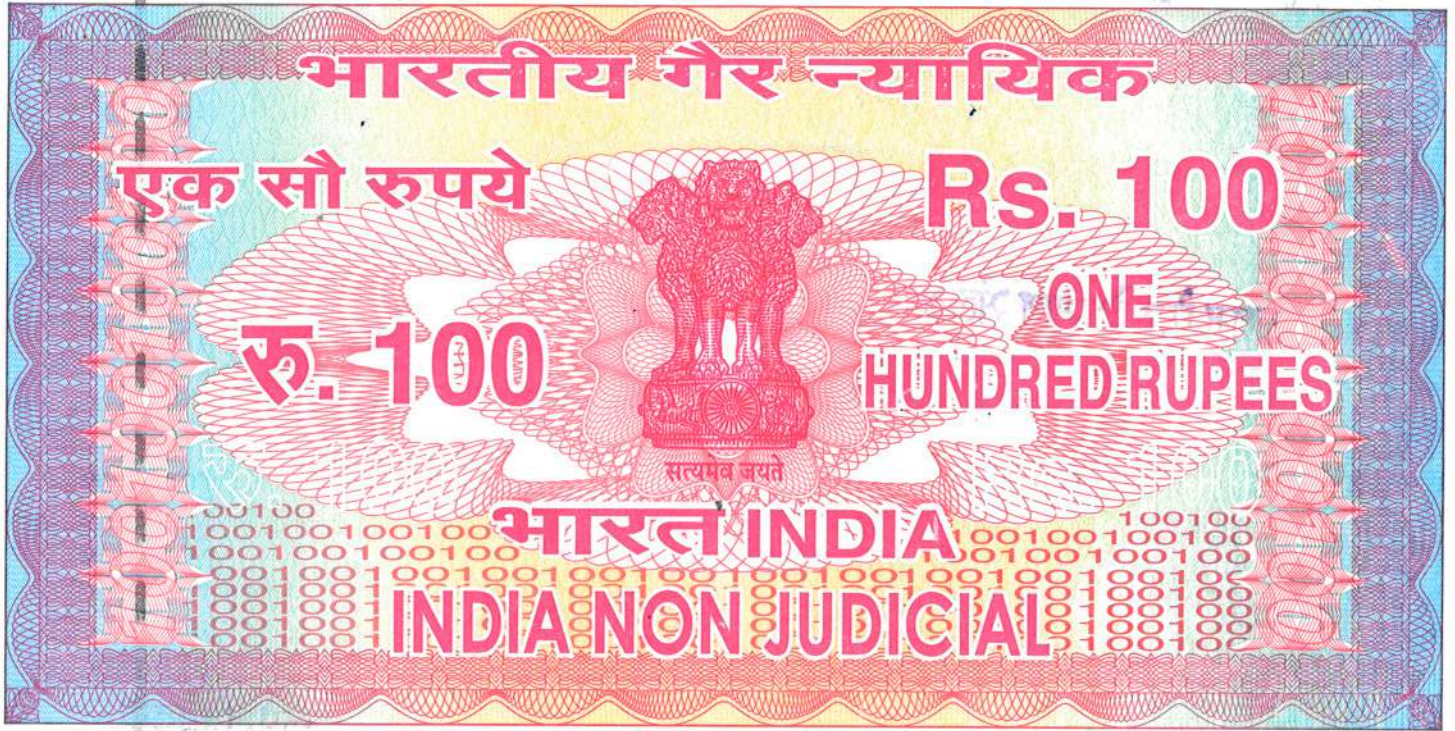

- (a) The Consortium of National Law Universities will provide LOGIN ACCOUNT from wherein actual CLAT-2021 Marks, Qualifying Marks, All India Rank (AIR) and the contact details of the candidates appearing for the CLAT 2021 can be accessed by **ORIENTAL UNIVERSITY INDORE**
- (b) The data base accessed from the above mentioned LOGIN ACCOUNT shall be used by **ORIENTAL UNIVERSITY INDORE** only and it should not be shared by **ORIENTAL UNIVERSITY INDORE** with any other University / Institution / College / Agency.
- (c) This does not in any way preclude the Consortium from sharing the actual CLAT Marks with any other agency other than **ORIENTAL UNIVERSITY INDORE**.

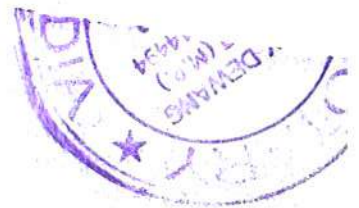

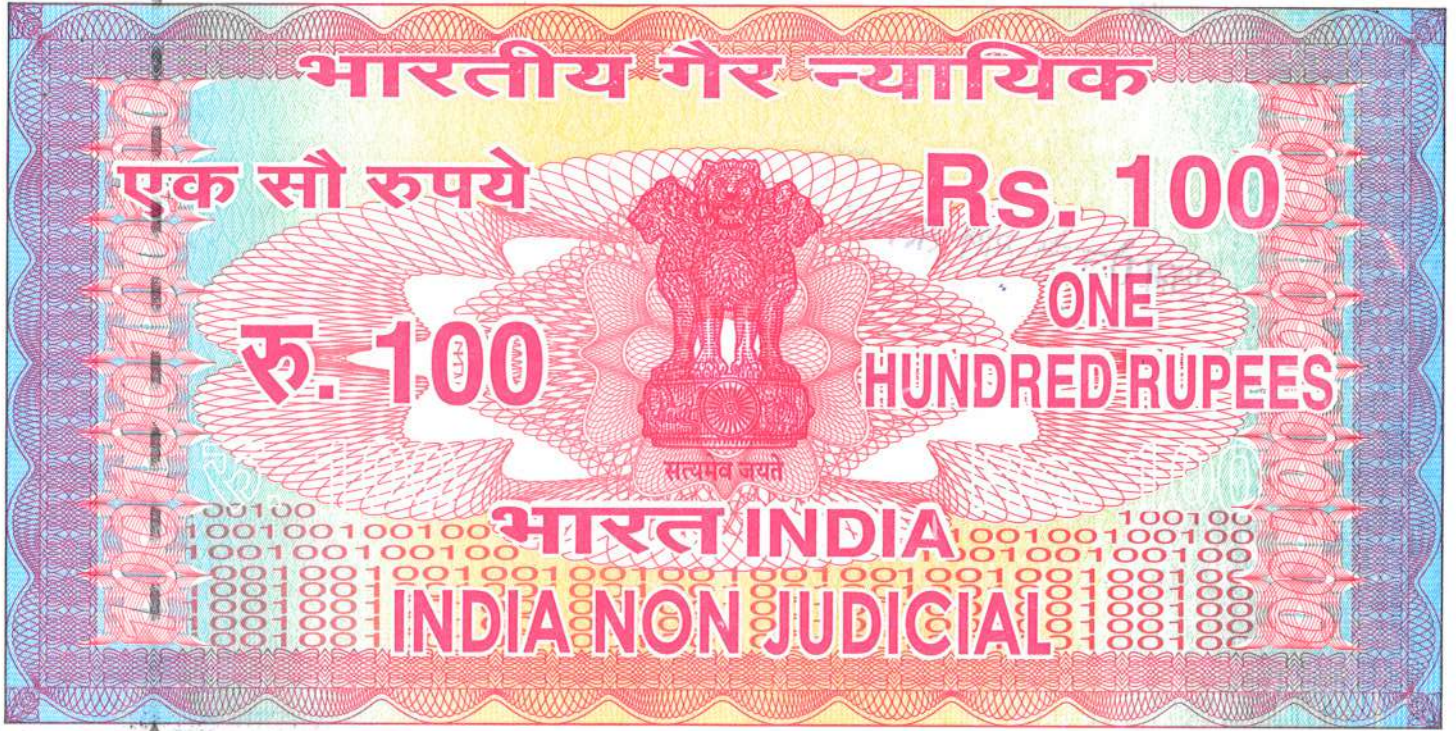

- (h) It will be the responsibility of **ORIENTAL UNIVERSITY INDORE** to advertise / inform respective candidates that **ORIENTAL UNIVERSITY INDORE** will be using CLAT-2021 Score for their admission purpose for the UG-CLAT 2021 Programme. This information will not be included in the CLAT Brochure / Advertisement. The **ORIENTAL UNIVERSITY INDORE** shall pay Rs. 10,000/- (Rupees Ten thousand only) to upload the name of the Institution in the CLAT 2021 website as an Institution having an MoU with CLAT 2021. GST at 18% will be added to the invoice.

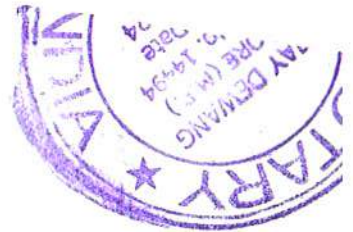

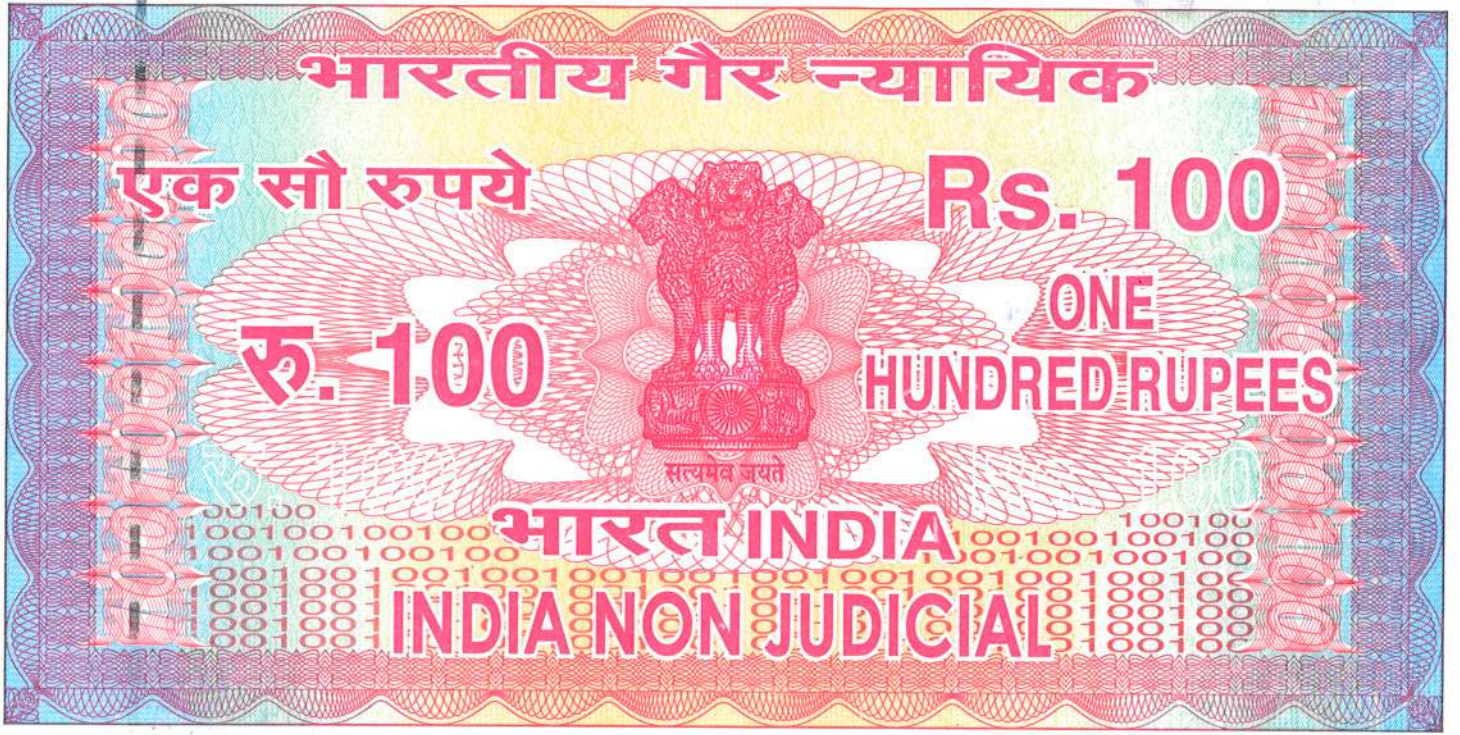

If not amicably settled within 60 (Sixty) days of the dispute or claim arising, such dispute or claim shall be decided by a Sole Arbitrator to be appointed by the mutual consent of the parties in accordance with the provisions of the Indian Arbitration and Conciliation Act, 1996. The parties agree that the decisions of the Arbitrator so appointed shall be final and binding upon the parties. The venue for the Arbitration shall be Bangalore.


