Anti Ragging Committee:

Ragging is strictly prohibited inside and outside the University campus. The Anti-Ragging Committee will monitor the measures taken by the University for the prevention of ragging, will look into the specific instances of ragging and complaints of ragging; and suggest appropriate action / punishment against individuals who indulge in ragging.



Objectives of Anti Ragging Committee

Anti-Ragging Committee will be the supervisory and advisory committee in preserving a Culture of Ragging Free Environment on the University Campus. The main objectives of this Committee are as follows:

- To prohibit any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student.
- To generate an atmosphere of discipline by sending a clear message that no act of ragging shall be tolerated and any act of ragging shall not go unnoticed and unpunished.
- To bring out an awareness among the students about the consequences of ragging.
- To make aware the students of dehumanizing effect of ragging inherent in its perversity.
- To keep a continuous watch and vigilance over ragging so as to prevent its occurrence and recurrence.
- To promptly and stringently deal with the incidents of ragging brought to notice.
- To address any ragging issues immediately and take action as advised by the committee.

Functions of Anti Ragging Committee:

- To uphold and comply with the directions of the Hon'ble Supreme Court and be vigilant on any acts amounting to ragging.
- To publicize to all students about prevalent directives and the actions that can be taken against those indulging in ragging.
- To consider the complaints received from the students and conduct enquiry and submit report to the Vice – Chancellor of the University along with punishment recommended for the offenders.
- Oversee the procedure of obtaining undertaking from the students in accordance with the provisions.
- Conduct workshops against ragging menace and orient the students.
- To provide students the information pertaining to contact address and telephone numbers of the person(s) identified to receive complaints/distress calls.
- To offer services of counseling and create awareness to the students.
- To take all necessary measures for prevention of Ragging inside the Campus.
