MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MoU) is entered into on 26/3/2024, by and between MALWANCHAL UNIVERSITY, INDORE (M.P.), located at Index City, Near Khudel, Nemawar Road, NH-59A, Indore, Madhya Pradesh -452015, and ORIENTAL UNIVERSITY, INDORE, located at Opp. Reoti Range, Gate No.1, Jakhiya, Sanwer Road, Indore.

BACKGROUND:

WHEREAS, both institutions recognize the importance of academic collaboration to enhance educational opportunities for their respective students and faculty;

WHEREAS, the parties wish to establish a framework for cooperation to promote mutual understanding and academic exchange;

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the parties agree as follows:

1. OBJECTIVES OF COLLABORATION:

The primary objectives of this collaboration include, but are not limited to, the following:

- a. Exchange of faculty members for teaching, research, and academic activities.
- b. Development of joint academic programs, workshops, and seminars.
- c. Facilitation of student exchange programs.
- d. Sharing of academic resources, research materials, and publications.
- e. Any other activity as mutually decided.

2. DURATION:

This MoU shall commence on 26/3/2024 and remain in force for a period of five years. Either party may terminate this agreement with written notice of one month.


3. RESPONSIBILITIES:

Both institutions agree to:

- a. Appoint a single point of contact to facilitate communication and coordination.
- b. Share relevant information and resources for collaborative activities.
- c. Jointly organize and fund agreed-upon academic initiatives.

4. FINANCIAL ARRANGEMENTS:

There shall be no financial responsibility on either of the party. Financial responsibilities related to collaborative activities shall be determined on a case-by-case basis. Both institutions commit to seeking external funding opportunities to support joint projects when applicable.

5. INTELLECTUAL PROPERTY AND CONFIDENTIALITY:

In respect of each event and program of cooperation, the parties shall negotiate and mutually agree in writing on their respective rights to intellectual property and commercial exploitation of the same (including without limitation, trademarks and service marks, copyrights, patents, designs, and confidential information pertaining thereto).

Both parties agree to maintain the confidentiality of any proprietary or sensitive information shared during the collaboration.

6. DISPUTE RESOLUTION:

Any disputes arising from this collaboration shall be resolved amicably through negotiations between the parties.

7. AMENDMENTS:

This MoU may be amended by written agreement of both parties.
